- Aaron Doss thanked the YCL members who came out and assisted with the recent public events and encouraged his fellow committee members to keep forging ahead in service.

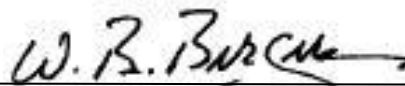
14. ADJOURNMENT
