Councilmember Gonzalez moved to certify the results and adopt Resolution No. 9084. Councilmember Velasco seconded the motion, which carried unanimously.

# RETIREMENT PRESENTATIONS TO MAYOR KERNES

City Manager Latham explained that concurrent with the certification of the election results and the swearing in of the new councilmember, Mayor Kernes would be vacating his position on the Council; at this time, staff would like to thank Mayor Kernes for his many years of public service and make some presentations to him. Department Heads Ana Alvarez, Jose Gomez, Alex Rodriguez, Paul Ashworth, Don Jensen and Fernando Tarin delivered congratulatory comments to Mayor Kernes and presented him with specialty T-shirts on behalf of each of their departments; pictures followed each presentation. Councilmembers Gonzalez, Velasco and Serrano also delivered congratulatory remarks to Mayor Kernes.

Mayor Kernes introduced his companion and presented her with a bouquet of flowers; pictures followed. Mayor Kernes gave brief remarks thanking Council and Staff for their support the past 32 years. He also congratulated Councilmember-Elect Rounds on his election and invited him to take his chair on the dais. The audience gave Mayor Kernes a standing ovation, and he left the dais.

Councilmember Rounds nominated Councilmember Velasco. Councilmember Gonzalez seconded the motion, which carried unanimously.

City Attorney Skolnik announced that, without objection, Councilmember Velasco will now serve in the capacity as Mayor Pro Tem.

Mayor Serrano presided over the remainder of the City Council meeting.
