**LOCAL APPOINTMENT LIST
"MADDY ACT"
(Government Code Section 54972)**

Pursuant to Government Code Section 54970, the Maddy Act, on or before December 31st of each year, the City Clerk posts a list of all ongoing boards, commissions, and committees, which are appointed by the City Council.

The City of Santa Fe Springs encourages residents to apply for positions on City committees and commissions. This can be done by obtaining an application from the City Clerk's Office, City Hall, 11710 E. Telegraph Road, Santa Fe Springs, CA, 90670, the City website at www.santafesprings.org, or by calling (562) 868-0511 ext. 7014.

Qualifications unless specifically provided by law or ordinance of the City Council, are as follows:

- 1) An individual must be a resident or have an established business interest in the City; in order to serve on a youth-based commission or committee, an individual must be a resident or attend school in the City.
- 2) The term of service for any individual appointed to a commission or committee shall be two years beginning in January 2025, and any individual appointed to fill an unexpired term shall serve for the unexpired portion of that term.
- 3) All commission and committee members shall continue in office until their successors are appointed.
- 4) The same individual may serve on no more than three commissions or committees, or any combination thereof, at any given time.
