Crime Prevention Tips and Statistics – Police Services

Detective Paul Garcia of the Whittier Police Department presented on the following:

- Fraud through phone calls has been a frequent problem. The scammer will call and ask you a question where you respond with "yes" and they will use your voice for a variety of things.
- Catalytic converter thefts have decreased.
- Vehicle burglaries, car thefts, sexual assaults, and indecent exposures have increased.
- Individuals are encouraged to be aware of their surroundings when they are out shopping, especially during the holidays. If you go shopping, make sure not to leave your purchases in your vehicle and then continue shopping. Individuals are looking out for this so they may break into the vehicle and rob the individuals purchased items.
- Individuals are encouraged to not leave their bags or purses in their shopping cart.
- Gangs from surrounding cities are triggering activity to happen in the City. Otherwise, gang activity has decreased.
