All Cat & Dog Spay/Neuter Rebate Program applications **MUST** be submitted with the required documentation. **It is important that all rebates follow the eligibility requirements stated below.** Failure to provide all necessary documentation will result in denial of the rebate, or potential processing delays. Rebate applications and documentation can be mailed by U.S. Mail or hand-delivered during normal business hours, Monday-Thursday, 7:30 a.m. - 5:30 p.m., to Police Services Center, 11576 Telegraph Road, Santa Fe Springs, CA 90670. Eligibility Guidelines & Checklist:

- To be eligible for the rebate, the applicant must be a full-time resident of Santa Fe Springs and be the person listed on the pet license. Organizations are not eligible for rebates.
- Limited to 2 pets per household, and rebate may only be claimed once every 5 years.
- The Santa Fe Springs Cat & Dog Spay/Neuter Rebate Program is a funding-limited, first-come, first-served program. Rebates will be issued to eligible applicants only while funding is available.
- All rebate-eligible cat & dog spay/neuter procedures are required to be performed by a licensed veterinary practitioner.
- Spay and neuter procedure must be reflected after July 1, 2025.
- Only cats/kittens and dogs/puppies are eligible.
- Rebates will be issued by check only to the name listed on both the application and the pet license. Please allow 30 calendar days for processing.
- Rebates will be issued up-to \$350 maximum for up to 2 pets. Only the cost of the spay/neuter procedure is eligible for the rebate with an itemized invoice.
- A valid Santa Fe Springs Pet License must be on file.
- Must have a current utility bill (water, electricity, gas, or phone) in your name, matching the Santa Fe Springs address on your valid government-issued ID. The utility bill must be dated within 60 days of your application submission.
