5. <u>Traffic Bureau Reports – April, May, June, and July 2023</u>

Sergeant Segura provided a summary, noting (1) Fatal, (20) Injury, and (35) Property Damage for April 2023; (1) Fatal, (15) Injury, and (26) Property Damage for May 2023; (0) Fatal, (24) Injury, and (23) Property Damage for June; and (1) Fatal, (19) Injury, and (32) Property Damage for July. The Bicycle Pedestrian reports noted (3) vehicle vs Bicycle and (1) fatal vehicle vs pedestrian for April 2023; (3) vehicle vs pedestrian and one bicycle vs pedestrian for May 2023; (1) vehicle vs bicycle and (1) vehicle vs

pedestrian for June 2023; and (1) motorcycle vs bicycle and (4) vehicle vs pedestrian. Additionally, he noted (79) traffic enforcement stops, yielding 73 citations.

The Year-to-Date High-Collision intersections for July 2023 are Florence/Norwalk (10), Telegraph/Shoemaker (10), Carmenita/Foster (5), Florence/Roseton (5), Los Nietos/Norwalk (5), and Bloomfield/Florence (4). The primary collision factors: Improper Turn (68), and Unsafe Speed (53), and 99 Moving Violations.
