4. APPROVAL OF MINUTES – A.J. HAYES, CHAIRPERSON

- 5. <u>COUNCIL LIAISON REPORT</u> –Mayor Pro Tem William K. Rounds reported on the following:
 - The annual Easter 'Eggstravaganza" was held on Saturday, April 20th at Los Nietos Park was well received by the public. The Egg Hunt area was doubled in size and therefore able to accommodate the large crowds. The Sister City pancake breakfast was well attended and pictures with the Easter Bunny was very popular.

- The Miss Santa Fe Springs Pageant will be held this Friday, April 26th at the Clarke Estate from 5 p.m. 9 p.m.
- The I-5 construction is scheduled to be complete by December 2019, if not sooner.
- Mayor Pro Tem Rounds assured the Committee Members that the Promenade is being monitored closely by WPD, Public Safety, and Code Enforcement. In the last month there has been over 100 patrols by WPD and Public Safety. The Octa-pharma – plasma and blood center in the Promenade has hired a security guard for the facility and parking lot around their location. The center has also instructed their employees to do an hourly trash pick-up around the perimeter of their store.
- Four Proclamations were handed out at the April 23rd Council Meeting for Autism, Testicular Cancer, Denim Day, and Older American Recognition.
- Mayor Pro Tem Rounds followed up on previously reported code violations and reported back to Doris Yarwood that the two concrete barriers on Florence under the train bridge have been removed.

- The City wide yard sale is being re-organized and will not be happening this year.
