# <u>Human Trafficking Presentation - Ray Bercini, Saving Innocence</u>

Mr. Ray Bercini, a retired detective with the Los Angeles County Sheriff's Department provided a presentation on Human Trafficking to the Family and Human Services Advisory members. Mr. Bercini now working with Saving Innocence, a non-profit organization, works with various local and federal task forces. The presentation included an understanding of how human trafficking is handled by law enforcement and victim services. These two different units include investigation, prosecution and services offered to victims. The presentation also included information on how to identify red flags and warning signs, understand the impact of commercial sexual exploitation and provided resources on how members can become a knowledgeable advocate in supporting children with lived experience & making a meaningful difference.
