Police Services - Crime Statistics

Detective Paul Garcia provided information on common crimes and scams that have recently taken place in Santa Fe Springs. In relation to robberies, there has been an increase in robberies taking place. However, it is not City residents committing the crimes, it is suspects who reside in a different city. There has also been an increase of possession and/or use of fentanyl; this is only seen in the homeless camps.

Detective Garcia provided a few different popular scams that have recently taken place. A few examples are lottery and sweepstakes, taxes, investments, home titles, romance, utility companies, "grandparent scams", and fishing scams. He informed members to be cautious and attentive when receiving any type of scam phone calls or messages. The scammer will always try to gather information and continue to be very persistent until they gather the information they need. Once a call has been traced and if the phone number is somewhere overseas, the United States of America has no jurisdiction, therefore nothing can be done. Unfortunately, many of the scammers are overseas.

There are also scammers in person, such as an individual claiming to be a contractor. There have been incidents where an individual will hire a contractor and the contractor will ask to be paid partially before finishing the job and they do not return once they have been paid. Scams related to home titles have recently increased. Detective Garcia recommends for home owners to visit the County Registrar and Recorder office in the City of Norwalk about every 6 months to be sure there hasn't been a change to the home title. The ones who are usually targeted are the home owners who are almost done paying off their mortgage or who have already fully paid off their home.
