Heritage Park Train Depot Meeting of Tuesday, October 15, 2013

MINUTES

The meeting was called to order by Chairperson Larry Oblea at 5:30 p.m.

2. APPROVAL OF MINUTES

A motion was made by Amparo Oblea and seconded by Astrid Gonzalez to approve the Minutes of July 9, 2013. The motion was carried unanimously.

3. CITY COUNCIL LIAISON REPORT

Mayor Richard Moore advised that he and City Manager Thaddeus McCormack have met with representatives of Ridgeline Company, current owners of the previous Powerine plant property, regarding the odor being emitted throughout the city. The City will be seeking to obtain an enforcement order from the Air Quality Management District (AQMD) mandating that the company comply by treating the water in the old refinery tanks and discharging it when it reaches a safe level. Part of this mandate includes a permit to treat with a new system established. Lastly, that the company give the City a plan, subject to the City's approval, to dismantle and remove the tanks. The reoccurrence of the emitting odor this past weekend occurred when a high level of sulfite was released when the company was in the process of replacing the filter systems. The company is currently working on the situation. The City has required the installation of a material that increases the PH balance to kill the sulfur within the next few days. The completion of the removal process and installation of new tanks is estimated to take one to two years.

Councilmember Rios also reported on the following programs and events:

- An exhibit of children's vintage books donated by Councilmember Bill Rounds is now in display at the City Main Library.
- The Library is featuring *Zombie Prom* on October 18 at 7:00 p.m. This program is for ages thirteen to seventeen. The program will include games and refreshments. In addition, the Library will offer *Creepy Crafts* for children ages seven and older on October 28 from 3:00 p.m. 5:00 p.m.
- The Activity Center is closed for the building of the Haunted House. The Haunted House will be held beginning October 28 through October 31 from 6:00 p.m. 10:00 p.m. Cost is \$3.00 for ages twelve and younger and \$4.00 for ages thirteen and older. The Activity Center will reopen on November 4, 2013.
- The Halloween Carnival and Costume Parade will be held on October 31 from 5:30 8:30 p.m. at Los Nietos Park.
- A Sugar Skull Workshop is scheduled on October 26 at Heritage Park beginning at 10:00 a.m. Cost is \$5 per person.
- The Native American Pow Wow will be held on the weekend of November 2 and 3, 2013 beginning at 10:00 a.m. each day.
- The City is moving forward in offering the farmers market year-around and will also be extending hours every third Thursday of the month from 12:00 p.m. 7:00 p.m. with free entertainment. The community response has been positive.

4. CITY MANAGER REPORT

a. **Measure S** – A reminder that the November 5 ballot includes a measure authorizing the increase of per barrel tax from 20 cents per barrel to 41 cents to 51 cents per barrel. The tax increase has been agreed to be paid by Breitburn Energy Company and E. Mitchell Company who are the two oil producing companies in Santa Fe Springs. More information will be available in the City's Newsletter. Also, the last day to register to vote is October 21, 2013 and the final day to request to vote by mail is October 29, 2013.

5. HERITAGE ARTS ADVISORY COMMITTEE LIAISON REPORT

Chairperson Larry Oblea reported on issues discussed at the September 24, 2013 meeting as follows:

Splash Pad Art Feature – The City Council approved as a Capital Improvement Project (CIP) the concept to convert park wading pools in compliance with ADA regulations. Public Works is preparing a cost analysis of each pool and cost options. Once Public Works has completed its report, this issue will be brought to the Heritage Arts Advisory Committee to commence discussion on a possible art concept.

Art Walk Map – Staff is working on creating an Art Walk Brochure to promote health and wellness. The map will denote the locations of all the Art In Public Places art pieces for the community to enjoy.
