# 5. APPROVAL OF MINUTES

# 6. PRESENTATIONS

a. Overview of the Go SFS Application – Kevin Perriman, Municipal Services Manager

Kevin Perriman, Public Works Manager, presented to committee members the GoSFS Application for purposes such as reporting graffiti and dump sites. Mr. Perriman also addressed the approximate time it takes for a report to be processed and completion.

### a. Family and Human Services Division and Program Projects Updates

Executive Secretary Carrillo provided a recap on the Family and Human Services Division programs and events. Members are encouraged to review the staff report for further information. Executive Secretary Carrillo provided a recap of the 2022 Art Fest event to include a video presentation.

Advisory Member Nakamura asked if the Independence Day celebration event would have section seating for groups in attendance. Mr. Ramirez informed members there will not be section seating, but the entire perimeter of the park will be fenced. He assured the committee he would convey their feedback to the Parks and Recreation Manager.
