#### 5. APPROVAL OF MINUTES

A motion was made by Astrid Shesterkin and seconded by Gilbert Aguirre to approve the Minutes for the April 12, 2022 meeting.

### 6. PRESENTATIONS

### a. Job Duties for Police Officer v. Public Safety Officer

Public Safety Officer (PSO), Lindsay Inman presented to committee members on the differences in job duties for police and public safety officers. PSO Inman informed members when and who to call in cases of emergency, minor neighborhood disturbances and disputes. Committee members discussed their concerns with Officer Inman and a brief dialogue took place.

## b. Santa Fe Springs Transportation Services

Bus Driver II, Laura Cabrera provided committee members updates on the taxi service program being replaced with general transportation. Ms. Cabrera stated the requirements to participate in the program are you must be residents of Santa Fe Springs, aged 60+, pick-up and drop-off must be within a 5 mile radius and notifying transportation if a caretaker is coming along to ensure proper space accommodations. A brief dialogue took place at the adjournment of Ms. Cabrera's presentation.

### a. <u>California State Library Inspiration Grant for Tech Lab for Seniors at the William Gordon</u> Learning Center
