5. <u>APPROVAL OF MINUTES</u>

6. PRESENTATIONS

a. Aquatic Center Facility Status – Gustavo Hernandez, Parks & Recreation Manager

Parks & Recreation Manager, Gustavo Hernandez, presented to committee members the status of the Aquatic Center repairs. Mr. Hernandez also discussed the costs associated with repairs, renovations, maintenance and staffing. He also stated that the department is actively seeking feedback for future designs of the Aquatic Center which can be found in the form of a QR Code survey on resdidents' water bill.

Advisory Member Janie Aguirre asked for an estimated completion date on repairs and renovations. Mr. Hernandez explained that there is no approximate completion date

because of the lenghty process involved in creation blueprints, finding a firm and funding.

Advisory Member Gilbert Aguirre asked why the pools were not properly maintained throughout the years and why proper repairs were neglected for so long. Member Aguirre also expressed his concerns in regards to the proper allocation of funds to maintain the pools. Mr. Hernandez assured Member Aguirre that it is a priority.

7. COUNCIL LIAISON REPORT – Councilmember, Dr. John Mora

Councilmember, Dr. John Mora informed the Advisory Committee that there was misinformation being spread about City Council and their involvement with the Aquatic Center. Dr. Mora clarified the rumors and informed members that City Council is actively trying to secure funding needed for the center.

Councilmember, Dr. John Mora shared that the carpool lanes to the I-5 freeway, off of Florence Ave. and Orr & Day Rd., are now open. Dr. Mora stated that the city is looking into freeway markers to place on the carpool lanes to avoid confusion with normal lanes.

Committee members asked Councilmember Mora questions and a brief dialogue took place.
