## 2. APPROVAL OF MINUTES

A motion was made by Jimmy Mendoza and seconded by Charlotte Zevallos to approve the Minutes of April 8, 2013. The motion was carried unanimously.

### 3. COUNCIL LIAISON REPORT:

- The Department of Fire and Rescue will be hosting an open house to celebrate the reopening of Station No.2 on Wednesday, May 8, 2013 from 11:00 a.m. to 2:00 p.m. Fire Station No.2 is located at 8634 Dice Road. They will be displaying equipment, providing station tours and the Firefighters Association will be hosting a free barbeque.
- On May 18-19, 2013 the Aloha Festival returns to Heritage Park. Festivities begin at 10:00 a.m. on Saturday. They will have food, traditional entertainment, and vendors selling Hawaiian arts and crafts. There will also be plenty of parking.
- The Santa Fe Springs Art Fest 2013 will take place at the Clarke Estate on Thursday. May 30, 2013 from 5:00 p.m. to 8:00 p.m. This is the first art exhibition for the City and the Heritage Art Advisory Committee. They will have music, refreshments and artist vendors. Over 300 pieces of art will be on display. The work will also be on display at the Library after the event from June 3, 2013 through June 28, 2013.
- On Saturday June 8, 2013 there is a City excursion to Temecula to visit antique dealers for one-of-a-kind items. The cost for this trip is \$7.00 and lunch is at your own expense. For more information call Town Center Hall.

- On June 4, 2013 the City's Fire Department will be offering a free fifteen minute hands only CPR training at either the Town Center Plaza or at the Wal-Mart Gateway plaza on Telegraph Road and Carmenita Road.
- Wal-Mart has a new store manager, Mr. Gil Salazar. Wal-Mart is proposing to install a shopping cart wheel locking system within the center.
- Fireworks training tomorrow May 7, 2013 from 5:00 p.m. to 6:00 p.m. in the City's Council Chambers.
- City Hall will be closed Friday May 10, 2013.
- Caltrans has informed the City of the following road closures:
  - 1. Long term full closure of Shoemaker Avenue between Rosecrans Avenue and Excelsior Drive during the reconstruction of the Shoemaker Bridge and continuing through Spring of 2014
  - 2. Full closure of Dollison Drive until September 2013.

- Santa Fe Springs will be holding their first Farmers Market on Thursday, July 11, 2013 from 12:00 noon to 5:00 p.m. in the Town Center Plaza.
