# 6. Conditional Use Permit Case No. 716

Request for approval to co-locate on an existing 50 foot high telecommunications facility, stealth as a mono-palm, and setback approximately 219 feet south of Imperial Highway at 13808¾ Imperial Highway (APN: 8044-030-009), in the M-1-PD, Light Manufacturing — Planned Development, Zone. (Cortel LLC for Clearwire US LLC).

Mr. Roger Spencer, representative for the applicant, Cortel LLC, was present in the audience.

Commissioner Rios asked for clarification on the address. Mr. Nguyen explained that the existing palm is located at 13808½, but the new co-located equipment will be 13808¾.

Commissioner Ybarra asked about the size of the equipment. Mr. Nguyen explained that the new antenna will be slightly wider but will still be housed within the palm structure.

Having no other questions, the Public Hearing was closed by Chairperson Oblea.

Commissioner Rios made a motion to approve Item No 6 as presented. Commissioner Ybarra seconded the motion, which passed unanimously.
