# 6. Conditional Use Permit No. 676.2

A request for extension of the operation and maintenance of a motorcycle parts installation, manufacturing, and sales use, located at 8807 Pioneer Boulevard, Unit E, in the M-2, Heavy Manufacturing, Zone. (Dan's Motorcycle Parts)

Mr. Henry Esqueda presented the subject case. The Applicant, Daniel Equihua, was in the audience.

Vice Chairperson Rios commented that the operation remained the same and let Mr. Equihua know he was a good tenant.

Commissioner Ybarra asked the applicant if they conduct testing of the motorcycles on site. Mr. Equihua answered that he primarily manufactures and sells high performance motorcycle parts and occasionally installs the parts, but no testing is done on site.

Chairperson Madrigal asked what types of parts are manufactured. Mr. Equihua showed a PowerPoint slide of the gearshift he designed for racing bikes. He noted that most of his sales are over the internet.

Vice Chairperson Rios made a motional to approve Item No. 7. Commissioner Ybarra seconded the motion, which passed unanimously.

Vice Chairperson Rios asked for an update on the medical marijuana dispensaries. She was advised that City staff is working with the City Prosecutor to finalize "Cease & Desist" notices to be mailed by the end of the month.

Mr. Collazo announced that the applicants had withdrawn their request to open a pawnshop at 14156 Rosecrans. Vice Chairperson Rios asked if they were still going to occupy the space at that address. Mr. Collazo said they plan to open a jewelry store where they can buy gold, but this use will not require a conditional use permit.

Mr. Collazo also advised the Planning Commission that the gas station on Telegraph and Painter had gone into foreclosure and the legal owner will take over and clean up the property.

Mr. Collazo announced the concert at Heritage Park on Wednesday, July 27.

Mr. Nguyen announced that the Quiznos by the Target store had closed and a Flame Broiler will be moving into that space.

Mr. Morrell announced that 5 Guys Burgers had their grand opening last week; Auto Zone will be relocating to the southwest corner of Telegraph and Florence, and Mandarin Inn had been remodeled with a new patio.
