6. Development Plan Approval Case No. 864

Request for approval to re-clad an existing 5,600 sq. ft. metal building (Building 1 – front building) on the property located at 13045 Los Nietos Road (APN's: 8167 005 004 & 013), in the M-2, Heavy Manufacturing, Zone. (Dan Samarin)

Chairperson Rios reopened the Public Hearing and announced that the case will be moved to the July 9th Planning Commission Meeting to allow the applicant additional time to review the conditions of approval.

Commissioner Johnston made a motion to continue the Public Hearing to July 9, 2012. Commissioner Zevallos seconded the motion, which passed unanimously.

A. Alcohol Sales Conditional Use Permit Case No. 15-2

Compliance Review of Alcohol Sales Conditional Use Permit Case No. 15-2 to allow the continued sale of alcoholic beverages for off-site consumption at Bob's Market located at 11605 Carmenita Road in the C-4, Community Commercial, Zone. (Sebastian Zambrano & Hyung Bok Yoon)

Commissioner Johnston made a motion to approve Item No. 7A. Commissioner Madrigal seconded the motion, which passed unanimously.

B. <u>Alcohol Sales Conditional Use Permit Case No. 20-2 and Entertainment</u> Conditional Use Permit Case No. 12-2

Compliance review of Alcohol Sales Conditional Use Permit Case No. 20-2 to allow the continued operation and maintenance of the serving of beer, wine, and distilled spirits for on-site consumption, and Entertainment Conditional Use Permit Case No. 12-2 involving live performances at the Rachada Thai Cuisine located in the M-2, Heavy Manufacturing Zone at 13416 Imperial Highway, within the Consolidated Redevelopment Project Area. Vice Chairperson Ybarra made a motion to approve Item No. 7B. Commissioner Johnston seconded the motion, which passed unanimously.

C. Alcohol Sales Conditional Use Permit Case No. 51-1

Compliance review of Alcohol Sales Conditional Use Permit Case No. 51-1 to allow the continued operation and maintenance of an alcoholic beverage use involving the storage, wholesale and distribution of alcoholic beverages at 10155 Painter Avenue, located in the M-2-PD Heavy Manufacturing-Planned Development, Zone located within the Consolidated Redevelopment Project Area. (Hong Chang Corporation/ Jay Sohn, Applicant)

Chairperson Rio requested clarification regarding the compliance review period. The recommendation indicated five (5) years and Staff's recommendation was three (3) years.

Luis apologized for the error and notified Chairperson Rios that the correct compliance review period was three (3) years.

A discussion occurred regarding the cemetery next door to the property. Paul Ashworth notified Planning Commissioners that the cemetery is tied to the owner of the CUP No. 51 and that at 2016 the owner has the option of

purchasing the cemetery for development and relocating the remains after every family member has been contacted.
