MINUTES REGULAR TRAFFIC COMMISSION MEETING CITY OF SANTA FE SPRINGS JUNE 17, 2010

1. CALL TO ORDER

Chairperson Radoumis called the Traffic Commission meeting to order at 7:08 p.m.

Chairperson Radoumis announced that this is the time when comments may be made by interested persons on matters not on the agenda having to do with any City traffic-related matter. There being no one who addressed the Commission, Oral Communications were declared closed.

4. REPORT FROM CITY MANAGER

This item was continued to the next Traffic Commission meeting.

5. REPORT FROM POLICE SERVICES

Traffic Officer Cook submitted a Traffic Bureau Report showing that there were a total of 52 accidents reported during the month of May 2010, which is a decrease from May 2009. Additionally, there were two driving under the influence incidents, three pedestrian incidents and no bicycle incidents. There were eight hit and run accidents reported. Moving Citations, Moving Violations and Parking Violations were all down for this month and there was an increase in Warning notices.

6. APPROVAL OF MINUTES

Commissioner Gaitan moved to approve the minutes of the Regular Traffic Commission meeting of May 20, 2010. Commissioner Zevallos seconded the motion, which carried unanimously.

7. Parking Restriction on Norwalk Boulevard s/o Florence Avenue

Recommendation: That the Commission recommend to the City Council that a parking restriction between the hours of 12:00 p.m. and 6:00 p.m., Monday through Friday be implemented on the west side of Norwalk Boulevard from a point 635 feet south of Florence Avenue to a point 990 feet southerly.

Mr. Lopez gave an overview of the request, location and history of parking restrictions in the area.

Commissioner Valenzuela moved to approve the recommendation. Commissioner Gaitan seconded the motion, which carried unanimously.
