

**MINUTES
REGULAR TRAFFIC COMMISSION MEETING
CITY OF SANTA FE SPRINGS
OCTOBER 21, 2010**

1. CALL TO ORDER

Chairperson Radoumis called the Traffic Commission meeting to order at 7:05 p.m.

2. ROLL CALL

3. ORAL COMMUNICATIONS FROM THE AUDIENCE

Chairperson Radoumis announced that this is the time when comments may be made by interested persons on matters not on the agenda having to do with any City traffic-related matter. There being no one who addressed the Commission, Oral Communications were declared closed.

4. REPORT FROM POLICE SERVICES

Public Safety Officer Collins submitted a Traffic Bureau Report showing that there were a total of 46 accidents reported during the month of September 2010, which is a slight increase from September 2009. Additionally, there were six driving under the influence incidents, one bicycle incident and no pedestrian incidents. There were 14 hit and run accidents reported. Moving Citations, Moving Violations and Parking Violations were all down for this month and there was a slight increase in Warning Notices.

5. REPORT FROM THE CITY MANAGER

Mr. Latham addressed the Commission regarding a ballot measure, "Measure S" and asked if anyone had any questions. There being no questions, Mr. Latham thanked the Commission for their time.

6. **APPROVAL OF MINUTES**

Commissioner Gaitan moved to approve the minutes of the Regular Traffic Commission meetings of August 19, 2010 and September 16, 2010. Commissioner Zevallos seconded the motion, which carried unanimously.
