1. CALL TO ORDER

Chairperson Gaitan called the Traffic Commission meeting to order at 6:05 p.m.

4. <u>Traffic Bureau Report – October 2012</u>

Officer Igros reviewed the Traffic Bureau Report for the month of October. The report reflected that there were 66 accidents reported during the month of October 2012, an increase from October 2011. There were three driving under the influence incidents, three bicycle incidents, and two pedestrian incidents. Moving Citations, Moving Violations, Hazardous Violations, and Parking Citations decreased during the month of October 2012 compared to October 2011. The Traffic Enforcement Index was at 8.0 for the month. The intersections with the most accidents for the month were Florence Avenue/Bloomfield Avenue; Florence Avenue/Shoemaker Avenue; and Telegraph Road/Bartley Avenue.

Commissioner Berg made a motion to receive and file the report for October 2012; Vice Chairperson Radoumis seconded the motion, which carried unanimously.

5. APPROVAL OF MINUTES

Commissioner Puentes made a motion to approve the minutes of the Regular Traffic Commission meeting of October 18, 2012; Commissioner Berg seconded the motion, which carried unanimously.

6. **COMMUNICATIONS**

Commissioner Madrid asked about the legality of residents parking on their lawn on street sweeping days. Mr. Negrete discussed the impacts of residents

parking in non-traditional locations, and encouraged the Commissioners to outreach within their neighborhoods discouraging this practice.

Commissioner Puentes noted that she enjoyed the recent presentation of the Interstate 5 Freeway expansion project, and requested an update from time to time in the future as the project progresses.

Chairperson Gaitan mentioned that a basketball hoop was set-up again on the street on Flallon Drive.
