4. Traffic Bureau Report for November 2016 & December 2016

Mr. Lopez reviewed the Traffic Bureau Report for the month of November 2016. The report reflects 48 collisions, which is a decrease of sixteen (16) compared to sixty-four in November 2015. There were two (2) collisions involving a person driving under the influence of alcohol/drugs; three (3) pedestrians and one (1) bicycle collision. There were twelve (12) hit-and-run collisions and three (3) collisions involving damage to city property reported. The three high collision intersections for the month were Florence Avenue / Shoemaker Avenue (2); Los Nietos Road / Santa Fe Springs Road (2) and Alburtis Avenue / Maxine Street (1).

Mr. Lopez reviewed the Traffic Bureau Report for the month of December 2016. The report reflects 87 collisions, which is an increase of eighteen (18) compared to sixtynine (69) in December 2016. There were six (6) collisions involving a person driving under the influence of alcohol/drugs; zero (0) pedestrians and one (1) bicycle collision. There were twenty (20) hit-and-run collisions and thirteen (13) collisions involving damage to city property reported. The three high collision intersections for the month were Florence Avenue / Shoemaker Avenue (3); Alondra Boulevard / Freeway Drive (2) and Norwalk Boulevard / Los Nietos Road (2).
