NEW BUSINESS

Traffic Bureau Report – March and April 2017

Officer Sanchez reviewed the Traffic Bureau Report for the month of March 2017. The report reflects sixty-one (61) collisions, which is a decrease of seven (7) compared to sixty-eight (68) in March 2016. There were two (2) collisions involving person driving under the influence of alcohol/drugs; four (4) pedestrians and one (1) bicycle collision. There were thirteen (13) hit-and-run collisions and six (6) collisions involving damage to city property reported. The three high collision intersections for the month were Florence Avenue/Orr & Day Road (2); Pioneer Boulevard/Florence Avenue (2) and Telegraph Road/Shoemaker Avenue (2).

Officer Sanchez reviewed the Traffic Bureau Report for the month of April 2017. The report reflects forty-nine (49) collisions, which is a decrease of twenty-seven (27) compared to sixty-eight (68) in April 2017. There were five (5) collisions involving person driving under the influence of alcohol/drugs; zero (0) pedestrians and three (3) bicycle collisions. There were ten (10) hit-and-run collisions and seven (7) collisions involving damage to city property reported. The three high collision intersections for the month were Telegraph Road/Painter Avenue (2); Bloomfield Avenue/Florence Avenue (1) and Bloomfield Avenue/Lakeland Road (1).

5. 2016 Top Ten Intersections for Collision Frequency

Of special note for this report was the introduction of three intersections that have never appeared previously on the Top Ten list; Alondra/Freeway Drive (South); Marquardt/Firestone Boulevard and Santa Fe Springs Road/Los Nietos Road. He indicated that due to definite collision patterns, further study would be done for the Florence Avenue/Shoemaker and Santa Fe Springs/Los Nietos Road intersections.
