She asked if there was any night work being conducted on the former Powerine Refinery site. Mr. Lopez commented that all of the tanks have been removed from the site and it could be work being done for the I-5 widening project, either the driving of piles or the demolition of the old bridges that are slated to be removed and replaced.

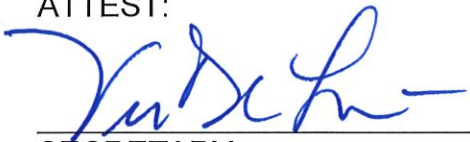
Ms. De León wished everyone a safe and Happy Father's day.
