NEW BUSINESS

Procedures for Setting Speed Limits on City Streets. 4.

Mr. Lopez presented Item 04 and outlined the fact that speed limits in and around Santa Fe Springs are normally set near the 85th-percentile per guidelines established in Section 2B.13 of the Manual of Uniform Traffic Control Devices. He provided two handouts for the area on Orr and Day Road between Florence Avenue and Telegraph Road. The first handout reflects the survey results for the Pace Speed, 85th Percentile and average speeds at that location. The second handout provided the survey results for the section of Orr and Day between Florence Avenue and Telegraph Road and it showed that the 85th-percentile speed had increased from 38 MPH to 47 MPH between 2009 and 2016. The report was informational and did not require any action by the Traffic Commission.
