# MINUTES REGULAR TRAFFIC COMMISSION MEETING CITY OF SANTA FE SPRINGS February 20, 2020

## 1. CALL TO ORDER

Vice Chairperson Coca called the Traffic Commission meeting to order at 6:10 PM.

# 5. <u>Traffic Bureau Report – January 2020</u>

Sergeant Reed reviewed the Traffic Bureau Report for the month of January 2020. The report reflects fifty-seven collisions, which is an increase of seven (7) compared to fifty (50) in February, 2019. For Collisions to Date 2020, the report reflects zero (0) Fatal; twenty-four (24) Injury; thirty-three (33) Property Damage. There are thirty-four (34) Injured Persons to Date, and zero (0) Persons Killed to Date. The Traffic Enforcement Index is 9.8 compared to 10.8 for January 2019.

There were two (2) collisions involving persons driving under the influence of alcohol/drugs; one (1) pedestrian and one (1) bicycle collision. There were fourteen (14) hit-and-run collisions and six (6) collisions involving damage to city property reported. The three high collision intersections for the month were Florence Avenue/Shoemaker Road (3) Auto/Right-of-Way; Alondra Boulevard/Marquardt Avenue (2) Auto Right-of-Way – Speed; and Florence Avenue/Norwalk Boulevard (2) DUI – Auto Right-of-Way.

Commissioner Collins made a motion to receive the Traffic Bureau Report for January 2020; the motion was seconded by Commissioner Miranda and was approved by the Traffic Commission by the following roll call vote:

# **6.** Parking Restriction – Orr and Day Road North of Hollyhock Street

Mr. Lopez informed the Commissioners that as a result of new information provided by the owner of Cherri's Donuts to the City after the report had been prepared, that it was requested that the Commission continue the item.

There was a brief discussion among the Commissioners and City staff to continue the item to give all parties affected by the parking request ample time to an agreed parking restriction time frame.

Vice Chairperson Coca made a motion to continue the request for a Parking Restriction on Orr and Day Road North of Hollyhock Street; the motion was seconded by Commissioner Collins and was approved by the Traffic Commission by the following roll call vote:

# 7. Parking Restriction Request - Smith Avenue west of Norwalk Boulevard

Mr. Lopez provided a presentation for the overnight parking restriction request received from Hansen Steel. Mr. Lopez noted that a "No Stopping Any Time Zone" parking restriction has been in place since 2016, to keep large trucks from parking adjacent to their driveway.

There is a remaining 400-foot long section with unrestricted parking available. However, due to trucks parking long-term, encroaching onto restricted areas, and partially blocking the easterly driveway to Hansen Steel. The only feasible option is to implement an overnight parking restriction on the 400-foot long section, along with a Tow Away Zone provision to curtail overnight parking.

Commissioner Collins made a motion for the Commission to recommend to the City Council to approve the implementation of a parking restriction between the hours of 9:00 PM and 6:00 AM on the north side of Smith Avenue west of Norwalk Boulevard, along with a tow-away zone within the same limits for vehicles that violate the restriction; the motion was seconded by Commissioner Miranda and was approved by the Traffic Commission by the following roll call vote:

- Bids were opened for the Florence Avenue Widening.

Mr. Lopez provided a Metro Fact Sheet for the Eastside Transit Corridor Phase 2. He indicated that it appears that the preferred route for Metro's L Line easterly extension project is the Washington Boulevard Alternative. Due in part to the anticipation of greater ridership, fewer environmental issues, and lower overall project costs.

Ms. De Léon provided a handout prepared by the City's Planning Department for the Active Transpiration Plan. There is a meeting scheduled for Wednesday, February 26, 2020, from 6-7 PM in the Council Chambers.
