4. Review of California Manual of Uniform Control Devices' Guidelines for Installation of Stop Signs

Mr. Lopez provided a PowerPoint presentation highlighting guidelines for the installation of Stop signs on City streets. He mentioned that originally, the Stop sign was developed to assign right-of-way at locations where the standard right-of-way rules did not work as intended and made evident by the number of collisions. Unfortunately, the Stop sign is now being used more and more to try to control the speed of traffic.

Mr. Lopez referenced the 2014 California Manual of Uniform Traffic Control Devices (CAMUTCD), which contains applications or guidelines providing minimum conditions to consider for the installation of Stop signs on public streets.

The report was for informational purposed only, and did not require any action from the Traffic Commissioners.
