Commissioner Miranda made a motion to have a parking restriction between the hours of 9:00 p.m. and 6:00 a.m. be implemented on both sides of Altamar Place from Dice Road to the westerly terminus along with a tow-away provision for violators; the motion was seconded by Chairperson Coca and was approved by the Traffic Commission as follows:
