Criteria

ALL APPLICANTS MUST MEET THE FOLLOWING ELIGIBILITY CRITERIA:

- 1. Must be a resident of Santa Fe Springs.
- 2. Be a senior currently attending Pioneer, St. Paul, or Santa Fe High School.
- 3. Provide proof of application to or acceptance from college(s).
- 4. Include a cover letter, written by applicant, with application.
- 5. Proof of good moral character, citizenship, and ethics via a letter of reference letter from a counselor, teacher, businessperson, or professional.
- 6. Cumulative GPA of 3.0 for the four years of high school.
 - Must submit unofficial transcript of high school grades with application.
- 7. Outstanding service to school (i.e., ASB, Clubs; AVID, Earth, Key) and community (i.e., volunteer work with non-profit organizations).

ARMANDO J. MORA

Biographical Information

Armando Mora was born in Los Angeles in 1926. He attended Roosevelt High School and East Los Angeles College.

He joined the United States Army at age 17 and served for four years. After his honorable discharge from military service, he married his wife Alicia in 1950 and had five children: Rosa, Anna, Armando, Irene, and Robert.

Employed by Sears, Roebuck and Company for 40 years, he worked as a Supervisor and Analyst and was also a member of the Sears Credit Union Board of Directors.

Mr. Mora moved to Santa Fe Springs in 1955 and became actively involved in the community. He held firmly to the belief that working for the betterment of the community was the greatest work one could do. Some of the community organizations and programs he worked with and served included:

- Chamber of Commerce Citizen of the Year
- Planning Commissioner
- Served as Councilmember from 1976 to 1985 (Mayor for three terms)

 - ♦ Renovation of the SFS Athletic Fields

 - ♦ Strongly supported the Santa Fe Springs Baseball Association

Councilmember Armando J. Mora passed away in 1985.
